

Memorandum of Understanding
ATYRAU STATE UNIVERSITY
(REPUBLIC OF KAZAKHSTAN)
and
YOZGAT BOZOK UNIVERSITY
(REPUBLIC OF TURKEY)

The provisions recorded below establish the principles and conditions by which Kh.Dosmukhamedov Atyrau State University (Republic of Kazakhstan) and Yozgat Bozok University (Republic of Turkey) agree to cooperate in academic exchanges, joint programme development and scientific research. Such a co-operative agreement will be progressed according to the following clauses:

Part 1

The purpose of this Memorandum of Understanding protocol is between two universities in undergraduate and graduate education; to develop and strengthen mutual understanding of science, research, culture and art.

Part 2

The Parties generally agreed to cooperate with each other in the following areas.

- Exchange of undergraduate, graduate and doctoral students;
- Bachelor's or master's / doctorate students in our university, students abroad for a semester or an academic year by paying the semester / annual fee (both their own university and the host university) can study as a guest student.
- Cooperation in the training of qualified experts, education and scientific personnel in mutually determined common areas,
- Exchange of knowledge and experience in educational work, curriculum development and ongoing educational activities;
- Organization of joint conferences, seminars, symposia, roundtables and other initiatives in the field of education and science;
- Organization of joint educational and scientific publications
- Training and retraining of the employees of the Parties, unless contrary to the legal objectives of the Parties;
- Providing Visa support to the representatives and students of the parties in the Exchange Programs.
- Providing free accommodation (dormitory) support to the representatives and students of the parties in the Exchange Programs.

Part 3

The conditions of the activities described in Article 2 and the financing conditions for the implementation of these projects shall be determined by separate agreements between the Parties.

Part 4

This Memorandum of Understanding may be amended at any time by an additional agreement which shall be an integral part of the Memorandum of Understanding with the written agreement of both parties and shall be properly registered and signed by the representatives of the Parties.

Part 5

All research and cooperation activities under this agreement shall be carried out in accordance with the laws and regulations applicable to each institution. Disputes arising from the interpretation and application of the provisions of this Agreement shall be settled through negotiations between the Parties.

Part 6

This agreement shall enter into force on the date of signature by both parties and expire at the end of five (5) years. The contract is automatically renewed for a period of five (5) years, unless one party notifies the other in writing that it wishes to terminate it. Such notification must be no later than six (6) months before the end of the previous period. The contract may be amended at any time with the written consent of both parties

Part 7

This agreement consists of seven (7) articles and is prepared in two copies in Turkish.

The Parties may prepare additional protocols where necessary.
