

**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE KHALEL DOSMUKHAMEDOV ATYRAU STATE
UNIVERSITY
AND
THE KOREA MARITIME INSTITUTE**

The Contracting Parties

The provisions recorded below establish the principles and conditions by which Kh. Dosmukhamedov Atyrau State University (Republic of Kazakhstan) and Korea Maritime Institute (Republic of Korea) agree to cooperate in academic exchanges, joint programme development and scientific research. Such a cooperative agreement will be progressed according to the following clauses:

Article1. Legal Framework of Both Parties

Both the Rector of Kh. Dosmukhamedov Atyrau State University and the President of Korea Maritime Institute may, in accordance with their respective policies and procedures, initiate agreements to enhance international good will and understanding and to further contribute to the achievement of their goals and objectives.

Article2. Goals and Missions of Both Parties

As a higher education institution and a national think tank with complementary missions, Kh. Dosmukhamedov Atyrau State University and Korea Maritime Institute share interests and objectives in academic exchange and joint research development matters. Both institutions are interested in establishing academic cooperation with institutions of a similar nature in order to assist in the achievement of their goals and objectives in such matters.

Article3. Purpose of the Agreement

Kh. Dosmukhamedov Atyrau State University and Korea Maritime Institute jointly agree to subscribe to a cooperative relationship in order to promote the following activities between both institutions:

- A. Exchange of research personnel
- B. Development in research activities
- C. Any other activity of mutual interest

Article4. Execution of the Agreement

Any arrangements entered into further to this memorandum will be governed by specific, individual agreements after due approval processes have been followed. All agreements will be signed between the relevant authority of the Kh. Dosmukhamedov Atyrau State University and the Korea Maritime Institute

Article5. Specific Agreements

The specific agreements between both organizations will detail arrangements including financial considerations, term of validity and administrative, operational and quality assurance responsibilities within each institution.

Article6. Term and Termination

The contents of this agreement may not be modified or amended except by written amendments duly executed by the parties. This agreement will be effective on the date it has been signed by both parties, and it will be in effect for a period of 1 year. This agreement will automatically renew at the end of each term for a further term of 1 year unless either party gives the other written notice of termination at least 30 days prior to the end of the relevant term. Termination of this agreement shall not affect any subsequent arrangements concluded by the Parties in the framework of this agreement.

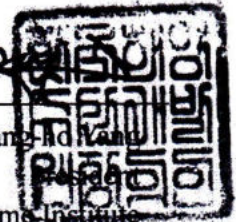
