- Original papers are accepted that have scientific and applied significance, correspond to the indicated areas and have not been published anywhere before.
- Volume of articles up to 8 pages in A4 format.
- The text must be typed on a computer in MS Word, Times New Roman font, size - 14, 1 interval, paragraph indentation 1.25 cm, margins: 2 cm on all sides; text - in width, do not hyphenate, do not set page numbering.
- The text of the article must be correct and free of errors. It is published in the author's edition. One author can publish no more than two works (including co-authorship).
- The title of the article is printed in capital letters, bold, centered, without a dot.
- After the title of the article below in the center in bold italics with a single interval in lowercase letters the surname and initials of the author (s).
- Below are the full name of the organization, city, country, e-mail.
- Further after indentation in 2 intervals the text follows.
- References (footnotes) to the literature in the text are placed in square brackets at the end of the sentence.
- Literature should be presented in the form of a general list. The numbering of literature is continuous.

The organizing committee reserves the right to reject articles that do not comply with the specified requirements, do not correspond to the topics of the conference, or are received after October 15, 2022.

Article structure:

- article title;
- information about authors;
- text of the article;
- bibliography.

The collection will be provided with appropriate BBK library indexes and an International Standard Book Number (ISBN)
