The articles of the participants will be heard at the sectional meeting of the conference on November 18, 2022 at 3.00 PM. Within the framework of the conference, sections will be organized in the following areas:

1. Cryptocurrencies: problems and development prospects in Kazakhstan
2. Cybercrime and cyber security strategies in the Republic of Kazakhstan
3. Development of financial technologies and non-cash payments in the Republic of Kazakhstan
4. Fintech - digital technologies in the financial sector
5. Development of the financial ecosystem in Kazakhstan
6. Digital technologies in taxation: evolution and main development trends in Kazakhstan
7. Digitalization in the securities market in Kazakhstan: problems and development prospects

The fee for the publication of an article related to participation in the conference is not charged. Abstracts of the conference materials will be published as separate collections.

Articles are accepted by the conference organizer until November 15, 2022.

Abstracts (articles) should be prepared in the following order:

- volume of work up to 3 pages;
- Windows 98/2000/XP; Microsoft Word 2003;
- Margin design: top - 2 cm, lower - 2 cm, left - 2 cm, right - 2 cm;
- font Times New Roman, font size – 12 pt;
- line spacing - 1; paragraph indent - 1 cm; portrait orientation, no headers or footers; alignment - in width
- In the Antiplagiat.ru system, the percentage of uniqueness of abstracts and articles must be at least 85%, materials are accepted by e-mail - zhumadilova_tolkyn@mail.ru
